
WEBSITE TERMS AND CONDITIONS

BACKGROUND:

This agreement applies as between you, the User of this Website or Purchaser and Metnano Limited (MNL), the owner(s) of this Website. Your agreement to comply with and be bound by these Terms and Conditions is deemed to occur upon your first use of the Website. If you do not agree to be bound by these Terms and Conditions, you should stop using the Website immediately.

No part of this Website is intended to constitute a contractual offer capable of acceptance. The Purchaser's order constitutes a contractual offer and our acceptance of that offer is deemed to occur upon our sending a dispatch email to the Purchaser indicating that the order has been fulfilled and has been dispatched. 1. Definitions and Interpretation

In this Agreement the following terms shall have the following meanings:

“Account”	means collectively the personal information, Payment Information and credentials used by Users to access Paid Content and / or any communications System on the Website;
“Carrier”	means any third party responsible for transporting purchased Goods from our Premises to customers;
“Content”	means any text, graphics, images, audio, video, software, data compilations and any other form of information capable of being stored in a computer that appears on or forms part of this Website;
“Goods”	means any products that MNL advertises and / or makes available for sale through this Website;
“MNL”	means Metnano Limited, Sparkhouse, Rope Walk, Lincoln LN6 7DQ;
“Service”	means collectively any online facilities, tools, services or information that MNL makes available through the Website either now or in the future;
“Payment Information”	means any details required for the purchase of Goods from this Website. This includes, but is not limited to, credit / debit card numbers, bank account numbers and sort codes;
“Purchaser”	means any person or business that buys Goods from MNL from this Website;
“Purchase Information”	means collectively any orders, invoices, dispatch notes, receipts or similar that may be in hard copy or electronic form;

“Premises”	Means our place(s) of business located at Sparkhouse, Ropewalk, Lincoln, LN6 7DQ;
“System”	means any online communications infrastructure that MNL makes available through the Website either now or in the future. This includes, but is not limited to, web-based email, message boards, live chat facilities and email links;
“User” / “Users”	means any third party that accesses the Website and is not employed by MNL and acting in the course of their employment; and

- 1.4 immediately to suspend your Account and cancel any unauthorised purchases that may be pending. Please be aware that purchases can only be cancelled until they are dispatched. In the event that an unauthorised purchase is dispatched prior to your notifying us of the unauthorised nature of the purchase, MNL accepts no liability or responsibility and you should make contact with the Carrier detailed in the Purchase Information.
- 1.5 When choosing a username Users are required to adhere to the terms set out above in Clause 9. Any failure to do so could result in the suspension and/or deletion of your Account.

9. Termination and Cancellation of Account

- 1.1 Either MNL or a User may terminate an Account. If MNL terminates your Account, you will be notified by email and an explanation for the termination will be provided. Notwithstanding the foregoing, we reserve the right to terminate without giving reasons.
- 1.2 If MNL terminates an Account, any current or pending purchases on your Account will be cancelled and will not be dispatched.
- 1.3 MNL reserves the right to cancel an Account and outstanding purchases without stating reasons, for any reason prior to processing payment and dispatch.
- 1.4 If purchases are cancelled for any reason prior to dispatch Purchasers will be refunded any monies paid in relation to those purchases.
- 1.5 If a User terminates their Account any non-dispatched purchases will be cancelled and a full refund of any monies paid in relation to those purchases will be paid through the payment method used when the Goods were purchased.

10. Payment

- 1.1 Any and all invoices are due for payment on the date shown on the invoice.
